Recently Deacon Greg Serangeli and Dr. Douglas Grandon informed me of the recent presentation made by Mark Middendorf and Terry Barber on behalf of Lighthouse Catholic Media. 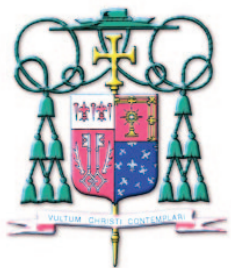
